FOSTERING A CAREER IN INFORMATION PRIVACY

The key responsibilities of the Privacy Officer are to ensure compliance with PIPA, advise company management and staff on the right measures to take, and to liaise with the Privacy Commissioner's office when necessary.



THE ROLE AND RESPONSIBILITIES OF THE PRIVACY OFFICER VARY AND ARE DEPENDANT ON THE WAY THAT THE ORGANISATION USES PERSONAL INFORMATION.



Business Solutions

Privacy Officers will need to be able to get buy-in for Privacy by Design & Default and often the benefits of a privacy programme to the organisation.



Good communicator

Privacy Officers should have empathy, patience, and determination. They need to know how to create a business case and to have confidence to face challenges.



Visionary

Privacy Officers need vision, the ability to inspire others, foresight to influence decisions and stay current with the ever-changing privacy landscape.



Investigator

Privacy Officers will need to ask tough questions, wear a risk management hat, detail clear notes, and offer a non-biased investigation after an incident.

Organisations should ensure that the Privacy Officer is positioned to respond to public inquiries, and has the resources and support to perform required duties.

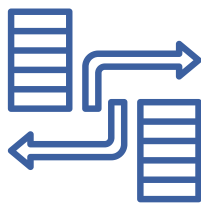

Embrace project management skills for team collaboration.



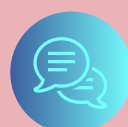
